## 2.0 Terms of Reference - points for discussion

- The SALON is acknowledged as a primary stakeholder in the original application for the Railway Building, and is well known as the historical artist representation group. The terms of reference recognise that the NRAH is focusing on how to run the management process, while the Salon (historical and future) driving the artistic vision of the two.
